ADMISSION NOTICE IN BS FORESTRY SESSION (2025-29) (2nd MERIT LIST)

All the listed candidates who are provisionally selected on merit for Admission to BS Forestry (2025-29) course against self-finance seats are directed to report to this Institute up till **October 21, 2025** during office hours otherwise, candidate next on merit will be offered admission. You should bring the following documents for submission at the time of reporting/joining.

- Bank draft for Rs. 1,697,000/- (Rs. One million, six hundred Ninety-seven thousand) as tuition fee & training expenses in favour of Director, Forest Education Division, Pakistan Forest Institute (PFI), Peshawar. Or through online payment into Account No. PK51NBPA0388003048615648 in National Bank of Pakistan, University Campus branch (code 0388), Peshawar in the name of Director, Forest Education Division PFI Peshawar. Receipt of online payment must be furnished. The amount be deposited in full. In case of needy candidates (written application is required) tuition fee & training expenses may be collected in 04 equal installments subject to approval of the competent authority. In such cases the amount of first installment is Rs. 425000. Rest of the amount is payable in three equal instillments at the start of each academic year.
- ii) Original academic certificates/DMCs from Matric onwards
- iii) Original Domicile Certificate.
- iv) Attested copies of academic Certificates/DMCs from respective Board.
- v) Three passport size photographs.
- vi) Migration certificate from the board last attended.
- vii) Undertaking on stamp paper of Rs. 100/- as per specimen, available at PFI web site.
- viii) Father's valid employment certificate for reserved seat candidates only.
- ix) Medical Fitness Certificate Issued by Senior Medical officer, PFI Hospital.

In case you are not willing to join, please inform in writing immediately. In case you fail to report by the stipulated date along with the required documents and bank draft or receipt of online payment, your admission will stand cancelled. Regular First Semester classes will commence from October 27, 2025.
