No.SO(Estt)FE&WD/V-20/2k19: In pursuance of the provisions contained in sub-rule (2) of rule 3 of the Khyber Pakhtunkhwa Civil Servants (Appointment, Promotion and Transfer) Rules, 1989, the Forestry, Environment & Wildlife Department, in consultation with the Establishment Department and the Finance Department, hereby direct that in this department Notification No.SO(ESTT)/FE&WD/V-20/2019/3891-3904, dated 16/4/2019, the following further amendments shall be made, namely:

AMENDMENTS

In the APPENDIX, against Serial No.93, in Column No.3 and 5, for the existing entries, the following shall be substituted, namely:-

“(i)	FA/FSc with second Division or equivalent qualification from a recognized board: and	18 to 30 years	<p>(i) Forty percent by promotion, on the basis of seniority-cum-fitness, from amongst the Daftaries (BS-4), Naib Qasids (BS-3), Khalasi (BS-3), including holders of other equivalent posts with two years services as such, who have passed F.A/F.Sc Examination or its equivalent qualification from a recognized board; and</p> <p>(ii) Sixty percent by initial recruitment.</p> <p>Note: For the purpose of promotion, there shall be maintained a common seniority list of the Daftaries (BS-4), Naib Qasids (BS-3), Khalasi (BS-3), including holders of other equivalent posts with reference to the dates of their acquiring the F.A/F.Sc qualification.</p> <p>Provide that-</p> <p>a) If two or more officials have acquired the FA/F.Sc qualification in the same session, the inter-se seniority in the lower post shall be maintained for the purpose of determining seniority in the higher post; and</p> <p>b) Where a senior official does not possess the requisite qualification at the time of filling up a vacancy, the official next junior to him possessing the requisite qualification shall be promoted in preference to be senior official or officials.</p> <p>Provided further that the condition of FA/FSc or its equivalent qualification from a recognized Board, as laid down at clause (i) shall not apply till the expiration of period as specified in second proviso of Column No.5 against S.No.4 of the Establishment Department's amendment Notification No.SOE.IV(E&AD)1-35/2014, dated 18.7.2019, to the existing matriculate incumbents of the post of Daftaries (BS-4), Naib Qasids (BS-3), Khalasi (BS-3), including holders of other equivalent posts for promotion to the post of Junior Clerk (BS-11)”.</p>
